Subject: Limited Tender for purchase of Miscellaneous Carpentry Items for Rajiv Gandhi Institute of Petroleum Technology, Jais, Amethi.

Introduction:

Rajiv Gandhi Institute of Petroleum Technology, Jais, Amethi has been set up by the Ministry of Petroleum and Natural Gas as an “Institute of National Importance” along the lines of IIT’s under an Act of Parliament. RGIPT is co-promoted as an energy domain specific institute by six leading Oil Public Sector Units (ONGC, IOCL, OIL, GAIL, BPCL and HPCL) in association with the Oil Industry Development Board (OIDB). The Institute is associating with leading International Universities/Institutions specializing in the domain of Petroleum Technology.

RGIPT, Jais is situated on Rae Bareli – Sultanpur National Highway, Near Jais railway Station at a distance of 27 km from Rae Bareli and spread over a land area of 47 Acres. The nearby Nagar Palika is Jais, which has a periphery of around 2.5 Kms.

Sealed tenders are invited for purchase of Miscellaneous carpentry Items for Rajiv Gandhi Institute of Petroleum Technology, Jais, Amethi. The details are attached with this tender document as **Annexure – A & B.**

Method of submission of Tender: This is a Single Part Tender. The Sealed Envelope containing tender document (duly filled in, signed & stamped all pages on **Annexure - A & B**) along with EMD and duly super scribed with tender enquiry number **RGIPT/JAIS/Misc Carpentry Items/Tender/2019-20/02, Dated – 19.06.2019, Tender for purchase of Miscellaneous Carpentry Items** and should be sent to either by courier / post or dropped in the tender box provided at 1st floor of Administrative building, Dispatch Section, RGIPT Office,

Bahadurpur, Mukhatiya More, Harbanshganj, Near Jais Railway Station, Amethi on or before by 10th July' 2019 till 15:00 Hrs.

Bidders are advised to enclose photocopies, as asked in 'Annexure-A' and must quote their rates for given brand / quality only, as mentioned in 'Annexure-B'. It is the responsibility of the Bidders to ensure to quote for each and every item, as asked in the tender document.

Bidders are required to submit Earnest Money Deposit (EMD) of Nationalized Bank, in the form of Demand Draft, for an amount of **Rs.3,800/- in the favour of "Rajiv Gandhi Institute of Petroleum Technology"**, payable at 'Jais'. In case, if the tender is submitted without EMD, in such case, the tender will be summarily rejected without assigning reason thereof.

In case, if it is found that the bidder has not quoted the rate as per the mentioned brand / quantity or has quoted the rates for any other brand / quantity or has not quoted for each and every item respectively, in such cases, his bid will not be considered in the financial evaluation of the tender. The EMD of the L1 bidder will be returned after the satisfactorily supply of the material at the institute. The EMD shall be returned to the unsuccessful bidders after finalization of tender without any interest.

The quoted rate shall be inclusive of all taxes and shall remain firm till the finalization of the tender. Billing of L1 bidder will be done as per GSTIN Act by mentioning HSN code of each item in the Invoice / Bill. The payment will be made either by Account Payee Cheque or through RTGS/NEFT after making all the statutory deduction like TDS etc and after successful delivery of miscellaneous carpentry items at RGIPT Jais campus to the satisfaction of the Engineer-In-charge.

Evaluation Criteria: Your quotation shall be valid for 120 days from the date of opening of tender. **The tender job will be awarded on overall L1 basis, not on individual item basis. L1 will be decided on the basis of sum total of all the items and applicable taxes etc. In case of tie between the bidders, order will placed on the basis of 50:50 ratio.** Signature and seal of the bidder is required on all the pages which are to be submitted along with tender document.

The tenders will be opened on the same date at Conference Room, 2nd floor, Admin Block of the Institute at 16.00 Hrs. in presence of bidders. The tender bids received beyond the stipulated period time and date shall not be considered for evaluation.

The clarification if required may be obtained from the administrative office on any working day between 11:00 Hrs. to 16:00 Hrs. from 19.06.2019 to 10.07.2019 on 9565993399. The quoted rate shall be inclusive of all taxes and shall remain firm till the finalization of tender.
