NOTIFICATION

Subject:- Code of conduct for the students of the Institute.

A section of the UG Ordinance is reproduced below for the information and necessary adherence of all concerned. As per UG Ordinance, Clause 12.1;

“Each student shall conduct himself/herself in a manner befitting his/her association with an Institute of national importance. He/she is expected not to indulge in any activity which is likely to bring down the prestige of the Institute. He/She should also show due respect and courtesy to the teachers, administrators, officers and employees of the Institute, and good neighborly behavior to fellow students. Due attention and courtesy is to be paid to visitors to the Institute and residents of the Campus. Lack of courtesy and decorum, unbecoming conduct (both within and outside the Institute), willful damage and/or removal of Institute property or belongings of fellow students, disturbing others in their studies, adoption of unfair means during examinations, breach of rules and regulations of the Institute, noisy and unseemly behavior and similar other undesirable activities shall constitute violation of the Code of Conduct for students. Ragging in any form is strictly prohibited and is considered a serious cognizable offence.”

Violation of Code of Conduct is an Act of Indiscipline and punishable under the Clause 12.2, UG Ordinance as follows;

“Violation of the Code of Conduct shall invite disciplinary action which may include punishment such as reprimand, disciplinary probation, fine, debarring from examinations, withdrawal of scholarship and/or placement services, withholding of grades and/or degrees, cancellation of registration and even expulsion from the Institute.”
