An Online Pre-Bid Meeting is held on 17-02-2023 at 11.00 AM to clarify the doubts of the prospective bidders. Representatives of four CA Firm have participated in the online meeting and clarified their doubts.

Based on the discussion with the participant's, following amendments are made in the tender ref no- RGIPT/Jais/Admin/2022-23/01:

1. A word '**Institute**' as mentioned in the tender no- RGIPT/Jais/Admin/2022-23/01 shall be read as 'Educational Institution' and 'an Institution of National Importance' for the purpose of providing services to these Institutions by CA Firm.
2. Any relevant services (as mentioned at Para-II & III from page nos- 5 to 10) provided by a CA Firm/Bidder to any '**Institution of National Importance**' shall be considered at par with 'RGIPT, IITs, IIMs, NITs, IISERs or Central Universities of Government of India' for the purpose of eligibility criteria as well as marking parameters.
3. **Refer Point No-9, Part-III (Page-10):** This point has been merged with Job-1 at Page-08.
4. **Refer Point No-2 of Part-VI (Page-15):**  
RGIPT is located at Jais, Amethi, Uttar Pradesh. RGIPT will provide lodging and boarding facilities to CA team at Institute's Guest House during official tour free of charges. CA Firm invited on campus for official assignment shall also be reimbursed the cost of to and fro travel by road/train from their place to RGIPT, Jais, Amethi on shortest route as per Institute's rules on the production of duly certified GST bill.

### It shall be read as

"RGIPT is located at Jais, Amethi, UP. RGIPT will provide lodging and boarding facilities to CA team at Institute's Guest House during official tour free of charges".

Job-8 (Page-10) has been merged with the Job-5 at Page-9. Bidder shall quote their price under Job-5 only.
