Terms & Conditions:

- The quoted rate should be inclusive of **GST & Freight charges**. Agency is requested to only fill the required data in BOQ, no extra terms and condition should be mentioned by the Agency. If he does so, then the quotation of that agency will be summarily rejected.
- The quoted rate shall be valid for a period of 60 days from the last date of submission of quotation.
- GST number should be mentioned in the quotation.
- The total time for completion of work will be 7 days. The date of commencement shall be reckoned from the date of acceptance of Work Order.
- No advance payment will be made. The agency should inspect the site before quoting the rate and payment will be made on basis of actual measurement of area.
- The quantity of items in BOQ is tentative which may change depending upon the site conditions.
- The quantity of items in BOQ is tentative which may change depending upon the site conditions. Mode of measurements will be as per Central Public Work Department (CPWD) specifications and Indian Standard (IS) codes.
- The work will be carried out as per BOQ, drawings & satisfaction of Engineer-in-Charge.
- In case of any damage and delay in completion of work, liquidated damages (LD) at the rate of 0.5% of the work order value per week of delay or part thereof, subject to a maximum of 10% of the work order value shall be recovered from the agency/contractor bills.
- The quotation should be sent to us duly **Signed and Stamped** only in **Sealed Envelope** and Super scribed as **Ref. No. RGIPT/JAIS/HO/QE/2025-26/02, Quotation for providing and installation works for construction of Box Cricket court and football court at RGIPT, Jais Campus** by registered post or by hand to the office of The Head Warden, Hostel Office, Rajiv Gandhi Institute of Petroleum Technology Jais, Mukhetiya More, Harbanshganj, Tiloi, Amethi, UP – 229304.
