Medical Reimbursement Policy for Students
(RGIPT Bangalore Centre)

Guidelines

1. All registered students of RGIPT Bangalore are entitled for this reimbursement policy.
2. The consultation fee and cost of prescribed medicines, pathological and diagnostic tests prescribed by a registered medical practitioner shall be reimbursed to the students on submission of original bills against the prescriptions and it shall be made as per the existing institute norms which is being followed for all the staff and faculty of RGIPT.
3. In case a student gets admitted in a hospital for treatment then expenditure incurred for indoor treatment in the economy/general class of accommodation will be reimbursed by the Institute. If the student wishes to avail of treatment in a higher class, the difference in cost from the general ward class will have to be borne by the student.
4. There will be no reimbursement of treatments related to cosmetology/dental procedures/organ transplants/obesity/maternity/infertility etc.
5. There will be no reimbursement for Ayurvedic/Homeopathic/Unani treatments.
6. Treatment of chronic cases or prolonged illness requiring special medical treatment for a long period will be responsibility of the parents/guardians of the students.
7. There will be no provision for medical advance.
8. A medical reimbursement claim form to be filled up by the students and attach all relevant prescriptions and medical bills/receipts and it is to be submitted in the institute's office within one month of finishing the treatment. The reimbursement shall be made within one month of time once it is duly verified by the Centre In-charge of RGIPT Bangalore, Institute's Doctor and approved by the Convener, Institute Health Committee.
